Christine Tacon CBE

Experienced executive and non-executive director and government regulator, working at Chair level in the food and farming industry.

Christine combines strategic leadership with a good, practical understanding of private and public sectors, she has a strong commercial background with deep experience of the food chain, from growing through processing, branding, retailing and governance. She has worked at board level within a FTSE organisation and co-operatives and was the first government regulator for the groceries industry, founding the role of Groceries Code Adjudicator (GCA). She has been recognised with a CBE; an Honorary Doctorate; Fellow of the Royal Agricultural Societies and international awards.

At the start of her career, she worked as an engineer in Germany and France. Since then, she has been UK-based but the GCA role was internationally pioneering, in post she worked with the European Commission and since leaving office, has done consultancy for Canada, Ireland, Denmark and New Zealand as they strive to implement similar regulation and has now been approached by Defra in relation to regulating the farmer to supplier chain.

As the first GCA Christine regulated the 13 largest retailers in the UK, a strategically challenging role but she achieved a significant culture change across the retailers, initially addressing specific practices and systemic issues and later ensuring that retailer governance was fit for purpose. Stakeholders included suppliers from one-man bands to international businesses, trade associations, NGOs and politicians. She developed a collaborative approach and magnified the impact of her work through constructive engagement with the media to reinforce and communicate her messages. She investigated Tesco in 2016 and the Co-op in 2019, both year-long investigations led to binding recommendations and an improved understanding of the Code across the grocery industry. She used an annual supplier survey to flush out and prioritise issues which demonstrated significant year on year progress across all the regulated retailers.

Christine has held P&L responsibility in over 10 businesses, including managing her way through complex government funding, designing a methodology and raising a levy to pay for the GCA office, and working with both internal and external auditors, including the National Audit Office. She was on the audit committee at the MET Office and the Rural Payments Agency, both public bodies.

She has a reputation in the food industry for being principled, fair, a disruptor for good and a change agent. She is keen to ensure synergy between the roles she has in order to make a difference in the food and farming industry and to influence the climate change and sustainability agenda.

Assured Food Standards (Red Tractor), Chair (Jan 2021-present) 30 days p.a.

An independent body owned by the UK food chain which manages and promotes assurance on behalf of the food industry and communicates the importance of the standards and British food to consumers.

A not for profit, member-owned organisation recruiting and training future leaders in the food and fresh produce industry. Trainees undertake four 6-month assignments in member businesses. Groceries Code Adjudicator, a BEIS Ministerial Appointment (2013-2020)

The role was established to encourage, enforce and monitor adherence to the Groceries Supply Code of Practice by the large UK grocery retailers in dealing with their direct suppliers, following Competition and Market Authority investigations. Christine was the first independent regulator and had the power to launch investigations and impose sanctions, including penalties up to 1% of UK turnover.

- Statutory reviews concluded the GCA was an "exemplary modern regulator with an international reputation" and was "highly effective"
- Improved compliance in all retailers demonstrated, and encouraged, through annual surveys
- Pioneered working in a collaborative way as a regulator, as well as using investigative powers
